# St. Andrew's Presbyterian Church, Perth, Ontario

## *...a brief history*

Perth was established in 1816 as a military settlement. The Scottish settlers wanted to have the Ordinances of the Gospel among them so they petitioned the Associate Presbytery of Edinburgh, Scotland for a minister.

Rev. William Bell arrived in 1817 and held his first service above Adamson's Red Inn on Craig Street. In 1818 he began the construction of a church on the corner of Drummond and Halton streets. It was completed in 1819, but was destroyed by fire in 1867. The bell was saved and later presented to St. Andrew's Presbyterian Church.

In 1830 work was begun on the first St. Andrew's and it was completed in 1833 at the corner of Drummond and Craig Streets.

In 1857, meetings were held between the sessions of First Presbyterian Church and St. Andrew's leading to a resolution to unite the two congregations. The first St. Andrew's manse was built on South Street looking up Drummond Street toward the church. The second manse was built at the corner of Victoria and Bolton Streets on the early 1880's.

On March 8, 1898 the final communion was held in the old church. Worship services were held in the Town Hall while the new church was being reconstructed due to the need for increased accommodation. The cornerstone was laid on June 7, 1898 and the new church was dedicated on January 29, 1899. This church was destroyed by fire in 1923.

In December 1923, St. Andrew's Hall was dedicated as the new place of worship. The site of the old church at Drummond and Craig Streets was sold in 1927.

***Laying of the cornerstone for the current church took place on July 19, 1927.*** The dedication of St. Andrew's Church at Drummond and North was held on March 11, 1928. In 1939, a third manse was bought at 8 Alexander Street and sold in 1947. A fourth manse was built in 1955 which is currently being used by the congregation as an outreach into the community under the name 'St. Andrew's House', located at 24 North Street directly behind the church building.

The Rev. Marilyn Savage has been serving within this congregation since 2002.

**FIRST SEDERUNT**

In the City of Perth, Ontario, and within St. Andrew's Presbyterian Church, on Friday the twenty-first day of October in the year of our Lord two thousand and eleven, at two o'clock in the afternoon.

At which place and time, the ministers and ruling elders being commissioners from the several presbyteries of The Synod of Québec and Eastern Ontario of The Presbyterian Church in Canada, convened as appointed by The Synod of Québec and Eastern Ontario held in the City of Ottawa, Ontario, in its final sederunt on the sixteenth day of October 2010.

The public worship of God was held in the sanctuary of St. Andrew's Presbyterian Church, Perth. The service was conducted jointly by the host minister, the Rev. Marilyn Savage and the Moderator, the Rev. Dr. Douglas Robinson. The Moderator preached the sermon, entitled "The Gospel Not of Human Origin". The Sacrament of Holy Communion was celebrated. Elders serving were Rob Allan, Frank Cameron, Marlene Gemmill and Walter Gemmill. The Director of Music, Ann Savage, provided music for the worship service accompanied by the choir of St. Andrew's Church.

**WELCOME**

On behalf of the session and congregation of St. Andrew's Presbyterian Church, Perth, the Rev. Marilyn Savage, welcomed the commissioners and guests to the 137<sup>th</sup> annual meeting of the Synod of Québec and Eastern Ontario.

A word of thanks was extended to the many volunteers from the host congregation capably providing hospitality in numerous ways.

It was noted that a St. Andrew's prayer group, co-ordinated by Walter Gemmill, was meeting between 3:00 and 5:00 in the afternoon keeping the synod in prayer.

**SYNOD CONSTITUTED**

Following the worship service, a refreshment break was held. At thirty-five past three o'clock in the afternoon, the Moderator, the Rev. Dr. Douglas Robinson constituted the Synod with prayer in the name of the Lord Jesus Christ, the only King and Head of the Church, to transact all the business which might properly come before it.

The convener entertained questions from the court as to the process followed in the preparation of the three Finance Committee documents. 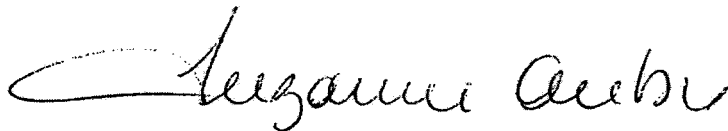

No directive was given as to the language of the work, therefore Synod has no authority to favour work in any specific language.

## Report of the WMS Synodical of Quebec and Eastern Ontario

The annual meeting of the synodical of Quebec and Eastern Ontario was a one day meeting hosted by the Montreal Presbyterial in the Presbyterian Church of Ile Perrot on Saturday, April 16<sup>th</sup>, 2011. This was the first time synodical had the opportunity to meet here and we were very pleased with the warm and welcoming atmosphere and for Ontario drivers the easy access. The theme of the meeting was 'Love in Action' and our guest speaker the Rev. Glyniss Williams told us some of the ways that volunteers befriend refugees who need help adjusting to life in Canada when they have lost everything and have had to endure the prison-like atmosphere of the holding centre. This was of special interest to us since one of the special projects of the WMS is raising funds for Action Refugies Montreal.

As synodical president I attended the abbreviated WMS Council meeting held the evening before the National Gathering of Presbyterian Women in Richmond Hill. One of the highlights of the meeting was the visit of five members of Presbyterian Women, USA, who spoke briefly of the kind of work they are involved with in their organization.

They were here to attend "the Gathering" which was held May 20-23, as were delegations from eleven other PCC partner countries. To say this gathering was a success would be an understatement. Where else would you find almost 600 Presbyterians of all ages dancing to the front of the church, or in this case the ballroom, to deposit their offering in a basket Nigerian-style. It was great to see the attendance of so many young women including several from Quebec and Eastern Ontario.

On September 26<sup>th</sup> we were warmly welcomed to Osgoode Presbyterian Church in Vernon, Ontario for the fall rally, using the theme "Seasons of Change". Anita Mack led an interactive bible study based on Luke 4: 35-41 on the fear and lack of faith of the disciples, and how we react to sudden changes in our lives. Our afternoon speaker was the Rev. David Pandy-Szekeres who serves with the Reformed Church of Sub-Carpathian Ukraine. He spoke and used pictures to tell of the challenges he and his wife Anna face working with the Christian schools for Hungarian students and outreach to Roma/Gypsy communities. Our group was moved to donate the offering to assist with this work.

We now have three members on the Regional Staff Committee, namely Ruth Davidson (convener elect), Mary Moorhead and Henny Donkersteeg. A search is on for one other, hopefully from Montreal Presbyterial.

The 2011/2012 Mission Study, *Ride the Cariboo Trail: Ministry and Mission Insights from Cariboo Presbyterian Church* is now available and a copy should have been received in all your churches.

Together with Catherine Blatch, Margaret Reynolds and Jean Macdonald, I will be attending the WMS fall meeting, November 3<sup>rd</sup> to 5<sup>th</sup> in Toronto.

Currently, the presbyteries' stats re: e-mail and church websites are as follows:

**Quebec:**

5 e-mail addresses, 1 church website  
(8 congregations in 8 charges, 4 vacant)  
100% of ministers have e-mail

**Montreal:**

38 e-mail addresses, 11 church websites - up from 6 in 2009  
(35 congregations in 33 charges, 8 vacant, 2 supply, 2 summer supply, 2 stated supply)  
100% of ministers and stated supply have e-mail

**Seaway-Glengarry:**

14 e-mail addresses, 13 church websites, up from 9 in 2009  
(27 congregations in 14 charges, 2 vacant, 1 stated supply)  
100% of minister, stated supply and one vacant charge have e-mail

**Ottawa:**

37 e-mail addresses, 19 church websites, up from 17 in 2009  
(20 congregations in 19 charges and one extension work, 3 vacant)  
100% of ministers and 2 vacant charges have e-mail

**Lanark-Renfrew:**

14 e-mail addresses, 6 church websites, up from 5 in 2009  
(21 congregations in 15 charges, 5 vacant)  
100% of the ministers and 1 vacant charge have e-mail

In total 100% of the ministers and known stated supply have e-mail addresses, as well as several of the vacant charges. In the entire synod only 16 of the 111 congregations in 89 charges do not have known e-mail addresses. Awesome! *(note: in an increasing number of cases churches may have two or more e-mail addresses, including one for the church office and one or more for the clergy; for these statistics, a church with an interim minister or various forms of supply have not been labeled vacant)*

The synod site consists of two main pages, one listing the churches by presbytery, including e-mail and web address links, and one listing the appendices and retired missionaries by presbytery, including e-mail addresses (where known). The listings are similar to those found in the back of the Acts and Proceedings. The main synod page also includes links to camp sites, a list of the Synod executive, reports for the Synod annual meeting(s) and links to various national church youth pages.

Listings are updated periodically based on input from contacts within the presbyteries and the list of changes sent out from the national church office, as well as occasional detective work using other sources such as ads and vacancy listings in the Presbyterian Record.

## **Regional Staff Committee Report**

The year began with hope that General Assembly would find funds to continue funding levels from 2010 but this was not the case. The five Presbyteries were contacted to determine the willingness of Presbyteries to continue to supply the needed funds as was done in 2011. The response was relatively positive and so the committee presents recommendation 2 below to address the funding shortfall for the year 2012.

There are still some concerns regarding the contract and job description as well as the overall goals for Regional Staff. Although a contract was approved last year by Synod it has yet to be signed. A request was made to the Presbyteries for feedback but this proved to be less than fruitful. Over the next year, the committee will evaluate the regional staff positions by asking for feedback from the synod and synodical. A questionnaire/survey will be sent to the Presbyteries and Presbyterials to see what the WMS, congregations and Presbyteries see as goals and expectations for the Regional Staff workers. The committee will compile the results and after analysis make a recommendation to synod in 2012 regarding the regional staff job description(s) and contract. Upon this review the committee will also make further recommendations regarding funding from Synod.

Pending the approval of Synod Council's recommendation regarding the Synod Youth Committee the Regional Staff committee recognizes that some of the advocacy of the former committee will rest with them as a committee of Regional Staff.

The committee is happy to see that Camp D'Action Biblique has found an executive director which has lifted those duties from Anita's shoulders. The committee is grateful for Anita's extra work at CAB over the past few years recognizing that her leadership was essential and needed and has contributed greatly to its ongoing mission.

## Regional Staff Report to Synod 2011

### Christine Ball

I have been pleased to serve the Synod of Quebec and Eastern Ontario for the past ten years. The job has evolved and changed as the demands and needs of congregations have changed and each month and year has been a little different. I would like to think that this is the type of ministry that is responsive to the current needs of congregations. I enjoy the variety of tasks and requests that arise from congregations.

I think that the Synod of Quebec and Eastern Ontario has developed a good model for regional staff that is unique to our synod. The region I cover (Presbytery of Lanark Renfrew, Presbytery of Seaway-Glendale and the Presbytery of Ottawa) is smaller geographically than any of my regional staff colleagues but the job description has been broader than other Regional Staff. This fact means that I may be invited into a congregation in multiple capacities Mission Education, Congregational Development, Christian Education and Youth. This is a real advantage for me in fully understanding and more effectively respond to the congregations as each has its own unique character. In a single congregation I may be invited to participate in elder training, training Sunday School teachers, attend a mission event, help congregations implement "Leading with Care", lead a spirituality workshop or support work with the youth and children.

I was recently asked by one Presbytery what I have been doing for congregations in the Synod?

Elder Training: New Elder Training, Re-visiting Ordination Vows, Term Service for Elders, Pastoral Care, Prayer, Growing in Faith.

Teacher Training: Individual work with Superintendents of Sunday School, CE Meetings and Year Planning, Curriculum Options, New Curriculum Orientation, Young Children and Worship Intro and Training, Teacher Appreciation and Enrichment, Lesson Planning, Special Needs Children, Age Group Characteristics, Inter-generational Worship.

Leading With Care: Introduction to the Policy, Board of Managers Building Survey, Leading with Care Committee/Session Check List, Teacher Orientation, Group Teacher Interview, Discipline, Fire Procedures, Epi Pen Training.

Natural Church Development: Coaching: Introduction to NCD, Planning for the Survey, Conducting the Survey, Entering Data, Interpreting and Understanding the Data, Planning and Implementation.

Congregational Support: Prayer and Pastoral Care, Spiritual Gifts Inventory, Spirituality Centres, Spirituality Types Inventory, Welcoming and Greeters Workshop, Strategic Planning, Visioning, Mission Statement Workshop, Effective Teams/Spiritual Leadership, Communicating in Meetings, SWOT.

Youth Ministry: Leadership Development of youth, youth leaders, camp staff, and parents of youth. Bullying Workshops Communicating with your teen/parents, Discipleship, Youth and the Arts, Mission for Youth, Peer Ministry Training, Confirmation,

Support of Youth: Youth ministry forum in Ottawa, Soul Harbour Spirituality Centre, regional youth events, meet with sessions and CE teams re: youth ministry, workshops for youth worship, promotion of Youth ministries such as CY, YIM, Gracefield, Open Table, PCSS, Chaplaincy.

Mission: Promote missions, Mission speaker on Mission Sunday or special occasions, Presentations on the difference between PWS&D and Presbyterian Sharing, Support of WMS (worship, Bible study, devotions, induction of executive), introduce Congregational Mission Study, Support of CGIT.

I enjoy the daily contact with people and try to respond to email and phone calls requesting information and resources in a timely manner. This position has enabled me to make many friends and acquaintances in congregations across Eastern Ontario and I welcome opportunities to hear about what congregations are doing and serving.

## REPORT TO THE SYNOD OF QUEBEC AND EASTERN ONTARIO (2010-2011)

Anita Mack - Regional Staff for the Presbyteries of Québec and Montréal

The year 2010/2011 was a challenging one. It started with the 2010 Synod grappling with the funding cuts to Regional Staff. While some Presbyteries had prepared for the new financial reality, others had not. Although it was a bit hectic to have to deal with this unexpected business on the floor of Synod, I am grateful that the budget was carefully examined and that money was found to keep the two Regional Staffing jobs at 2/3 time. Some confusion around job description, job title and contract still needs to be ironed out.

Another challenge concerned Camp d'action biblique. In February 2011, the Presbytery of Quebec decided to redesign the organizational model of the camp and the CAB committee was therefore dissolved. However, the new structure did not get off the ground as easily as anticipated. The old CAB committee was reinstated in mid-May as the fast approaching camping season was in jeopardy. I spent six frantic weeks finding chaplains, counsellors, cooks, life-guard and kitchen help, doing publicity and getting the camp ready. Despite the initial scramble, the 2011 CAB ministry turned out very well in the end. We were blessed with Randy Johnston - an old friend of CAB - ready and willing to take on the part-time Executive Directorship of the camp. Best of all, thanks to Randy, Craig Dewar and other committee members, CAB is now fully accredited with the ACQ (Association des Camps du Québec).

Other than camp work (which has diminished greatly with the arrival of the Executive Director), I spend my time on congregational care, conflict resolution, clergy/leader support, providing resources, acting as a liaison between various arms of the church, report writing, facilitating fundraising for several ministries, preparation for Church Life committee meetings and other administrative duties. I was asked to write the Easter worship service for Glad Tidings, the Morning Watch for the *Look In Shout Out* women's conference and a report on this Women's Gathering for the Presbyterian Record. On occasion, I am invited to lead a Bible Study, do elder/leader training and provide workshops on topics such as *Leading with Care*, the Church Mission Study, Presbyterian polity, term service for elders, being a welcoming congregation and curriculum options. In the coming year, I hope to spend more time with the newer congregations in the Presbytery of Montreal so that they will become more firmly rooted within the Presbyterian Church in Canada. As 2012 is a *Canada Youth* year, I also expect to be involved with organizational aspects regarding this youth conference.

## BACKGROUND

“The following recommendation was made at the last meeting of the Synod of Quebec and Eastern Ontario, moved by James Hurd and seconded by Warren Wong, ‘that a committee be struck at the 136<sup>th</sup> synod meeting October 15-16, 2010, to examine the role, structure and function of synod, including place and location, to the end of strengthening ministry, and report to the synod council, with a subsequent report to the 137<sup>th</sup> synod meeting.’”

The Moderator, Rev. Doug Robinson named the following to the committee: Rev. Dr. Floyd McPhee, Convenor; Rev. Robert Martin (Seaway-Glengarry Presbytery); Joan Hilliard (Lanark-Renfrew Presbytery); Druse Bryan (Montreal Presbytery); Rev. Giancarlo Fantechi (Quebec Presbytery); Gordon Walford (Ottawa Presbytery).

The Committee met on April 28, 2011 at Knox Presbyterian Church in Vankleek Hill, Ontario. A document, REPORT ON SYNOD, by Michael Pettem, a letter from Rev. James Hurd, and Notes from the Presbytery of Montreal regarding the future of synod were received and discussed. Comments from representatives of the Presbytery of Quebec, and the Presbytery of Lanark-Renfrew were verbally presented. Over the next several months committee members shared through email their views regarding the present and future state of the synod.

The committee focused its attention around the question: what purpose, if any, does the synod have in the life and witness of the Church, and if it does have a purpose, what changes, if any, should be made in the way synod functions in the future.

Upon extensive reflection the committee decided that the synod does have an important and significant role to play in the Church, and this could be best realized in continuing to meet each year, rotating in different places throughout the five Presbyteries. The committee concluded that the synod should meet as a commissioned court, and in alternating years as a fully represented court using a conference style format. After considering the financial cost of holding a conference style synod every other year, the committee modified its view, as reflected in Recommendation 2. Excellent facilities may be available for a conference style synod at Notre Dame de la Providence Retreat House, 1754 St. Joseph Blvd., Orleans, K1C 7CG. Sister Jocelyne is the contact person at 613-824-1610. The Retreat House has 59 single rooms, with a large chapel, a large meeting room, and a smaller meeting room. Costs for synod were roughly estimated to be around \$75.00 per person, including 3 meals and accommodation. The committee suggests that \$6,000 would cover any increase in costs, as well as bringing in a Theme Speaker for the synod.

The committee also considered whether some synod committees had lost their usefulness and should be disbanded. It noted that the Mission Committee had recommended to synod in 2010 that it be eliminated. There are those on the Mission committee who feel the committee had had little or no influence on decisions made by Canada Ministries in allocating grants within the synod. However, there is also some hope that there will be a change under the new Canada Ministries/The Vine. Therefore, the Special committee will not be making any recommendations concerning the Missions Committee. The Youth Committee was another concern of the Special Committee. The Youth

Committee has not met during the past year and has no chair. Christine Ball, Regional Staff, sees the need of such a committee, especially because of its involvement with Canada Youth which meets every three years. The committee helps with registration of youth from our synod, recruiting qualified adult supervisors, organizing information evenings, arranging transportation, etc. On the other hand Anita Mack, Regional Staff, sees no reason for the committee to continue. Cultural differences between the two regions that make up the synod, distances for youth to travel to any event, lack of numbers of youth, lack of available time for youth to be involved in synod programs, are some of the reasons why Anita believes the synod committee has lost its reason for existence. The Special Committee believes that if the synod would change the mandate of the Youth Committee to deal only with the Canada Youth event, it would make sense to have the committee continue. Or, if a way could be found to transfer the responsibilities for the Canada Youth event elsewhere there would be little need for the Youth Committee to continue.

#### RECOMMENDATIONS:

The Special Committee believes that the Synod of Quebec and Eastern Ontario, consisting of the five present Presbyteries, does have a vital role to play in the life of the Church. It supports the view presented by James T. Hurd, that “the synod’s value is found within its purpose to offer the following:

- a gathering for pastors and elders,
- a court of the church for judicial review,
- an opportunity for exploring weighty matters (Book of Forms 274),
- an opportune time for providing education options,
- an occasion for fostering fellowship and strengthening ties.”

Based on the above description of the purpose and function of the synod, and believing that synod can further strengthen ministry within its bounds, the committee makes the following recommendations:

1. That the synod continue as a “commissioned court” except when it meets as a fully represented court at a conference style meeting. By being a commissioned court it provides Presbyteries the opportunity to select elders and ministers to represent them assuring that representatives from each Presbytery attend the synod meetings.
2. On a trial basis the synod meet as a fully represented court consisting of the constituent members of the five Presbyteries, every third year, beginning in 2013, in a conference style synod and that synod apply to the Life and Missions Agency for a conference grant to help pay for the additional costs.

## CAMP D'ACTION BIBLIQUE – October 2011

The camp continues to move forward with your thoughts and prayers. The following updates are submitted to the Synod of Quebec and Eastern Ontario for your information and consideration.

1. QCA Accreditation. I am pleased to report that Camp d'action biblique has been accredited by the Quebec Camping Association for 2012 camping season. This would not have been possible without the grant from the Presbyterian Church in Canada and the recurring funding that we receive from the Synod of Quebec and Eastern Ontario. Your patience, understanding and support has made this possible. On behalf of the Camp Committee thank-you very much.
2. I am also pleased to report that the Presbytery of Quebec and the Presbytery of Montreal have struck a combined committee to determine how we could make better use of the camp, how the two Presbyteries might work more closely together concerning the common objectives and to reflect together on the future direction. It is hoped that the initial meeting of this committee will be held in mid November.
3. CAB committee. Since May the committee have welcomed three new members: Rev John Barry Forsyth, Rev Ross Davidson and Kathleen Johanson an elder from Quebec City. We now have a total of eight on the committee.
4. Staff and campers for 2011. There were 69 camper weeks and 21 different staff (totaling 73 staff weeks) involved with CAB this past summer.
5. Part-time positions. Randy Johnston and John Janzen in the part-time positions of Executive Director and Maintenance help have worked out well. On the maintenance side, Gary Johnston, Michel Randlett and William Randlett also greatly contributed. The maintenance crew worked well together and the camp is in very good shape.
6. Open House July 2<sup>nd</sup>, 2011. A good time was had by all. The weather was great; Richard Bonetto led an inspiring worship service, with Antony Romarokoto on the keyboard. Everyone enjoyed an excellent supper and had the opportunity to renew acquaintances.
7. The following is the status of property projects:



- a. General Upkeep included numerous general maintenance and upkeep tasks;
  - b. New Washroom. Thanks to the Rev Luke Vanderkamp and family work on male guest bathroom progressed and prior to closing up the camp for the winter, the deck and railings were stained by Gary Johnston;
  - c. Old washroom; the new Motel was open for business mid July and is 98% complete. A \$10,000 grant from the PCC allowed the work to be done much sooner; and
  - d. Priorities for 2012. The priority items for next year are:  
Leveling of the Oasis (dining hall) and rewiring the electrical connection from the old to the new Bell Canada telephone pole. With a camp built primarily in the early 1960s there will always be maintenance jobs to do, finances permitting.
8. Fall retreat. A very successful fall retreat, led by Randy Johnston was held the weekend of September 9<sup>th</sup>-11<sup>th</sup>, 2011. The weather was great and the group of 14 campers and staff enjoyed an excellent weekend of fellowship with the theme "on the rock" highlighted by an outing to Baldwin Mills.

10. Financial. I am pleased to report that we remain in the black and, to a large extent, have been able to continue operating because of the generous support of the Synod of Quebec and Eastern Ontario through your annual contribution.

The Presbytery of Ottawa is pleased to submit this report on its oversight of the Board of Directors of the Gracefield Christian Camp and Retreat Centre.

At its October, 2010 stated meeting, the Presbytery of Ottawa received the bi-annual report from the Board of Directors of the Gracefield Christian Camp and Retreat Centre, which summarised progress on a number of issues and outlined some of the strategic planning underway, priorities being to focus and renew the children's camping programme; to develop a programme of directed spiritual retreats; and to engage the tent and trailer community. The 2010 camping season was the first under the leadership of the new Executive Director, Relena Lyddon Myers. The board reported a successful visit from the representative of the Quebec provincial camping association in mid-July secured the renewal of the camp's accreditation. On recommendation of the board of directors, the presbytery appointed Matthew Klassen, a member of Knox Church, Manotick, and an accountant with a major accounting firm, to the board to serve as treasurer for a three-year term.

At its November, 2010 stated meeting, the presbytery received a year-to-date financial statement to October 31, 2010 from the board.

At its January, 2011 stated meeting, the Presbytery of Ottawa approved the dispersal of the proceeds of the sale of the building of the former Erskine Church, Ottawa, which congregation amalgamated with Westminster Church, Ottawa in 2007. Part of these proceeds have been assigned to the Gracefield Christian Camp and Retreat Centre, and until their use is determined by the board of directors, have been invested with the consolidated portfolio of The Presbyterian Church in Canada.

At its June, 2011 stated meeting, the Presbytery of Ottawa re-appointed to the board for a three-year term Terry Flett of Gloucester Church, Ottawa, and appointed David Kilgour, a member of Westminster Church, Ottawa and a long-time former Member of Parliament; and Peter Lamont, a member of St. Andrew's Church, Ottawa and a lawyer.

At its June, 2011 stated meeting, the presbytery also received a report from the Board of Directors which included preliminary but unreviewed financial statements for the year ending December 31, 2010, and the presbytery directed the board to present complete and reviewed statements to the October, 2011 stated meeting.

At its October, 2011 stated meeting, held October 18th, the Board of Directors reported that although it had held a special meeting in July, 2011 and engaged a new accounting firm which had given assurances that the financial review for the year 2010 would be completed for presentation to the board in late September, 2011, the review of the financial statements for the year ended December 31, 2010 was yet to be completed. The board also informed the presbytery that certain filings with the

Canada Revenue Agency were outstanding. The Executive Director and several members of the board met with the Business Committee of the presbytery and with the presbytery, at which these issues were discussed. The presbytery received assurances from the board that the Executive Director together with the members of the board were working to resolve the issues with the Canada Revenue Agency, and that the Executive Director was working with the auditors to finalise the 2010 financial review. The board also reported that going forward an accountant has been engaged to review financial statements on a monthly basis and report same to the treasurer of the board.

The Presbytery of Ottawa expects to receive at its November, 2011 stated meeting the completed and reviewed financial statements for the year ended December 31, 2010, year-to-date statements for 2011, and a comprehensive plan from the Board of Directors to address the financial situation.

The Board of Directors reported to the presbytery at the October, 2011 stated meeting that 2011 had been a fruitful summer with respect to its ministry to children, families, and adults, fostering exploration of and growth in faith and relationship to Jesus Christ, although the number of campers for the children's programmes was down approximately ten percent for the year 2011 compared to previous year. Many campers who did attend were permitted to do so through significant campership support, and the board indicated that it was reviewing the campership policies. The board also indicated that weekend bookings for the fall and winter were strong, but that numbers for congregational retreats have also been down.

The Presbytery of Ottawa was pleased to learn from the Board of Directors that significant progress has been made in designing and preparing for the installation of the new water treatment system, and that the board is awaiting approval from the provincial government in Quebec for the installation, which is scheduled to be undertaken either this fall prior to freeze-up, or, more likely, in the early spring of 2012. The presbytery continues to hold in trust the funds received from the synod for the water and septic system projects at Gracefield, pending the implementation of this work.

**THE REVEREND JAMES EDWARDS PHILPOTT**

James Edwards Philpott, whose lifelong passion was for Jesus Christ and the ministry of the Church, was summoned home to the nearer presence of his Lord and Saviour on April 2, 2011.

Born February 11, 1922 in Moulmein, Burma to missionary parents Henry and Anna Philpott, Jim along with his older brother Herb spent their early years in Atlantic Canada and in Ontario as his father served a number of rural and small-town congregations.

After his family moved to Montreal, Jim became more directly involved in Christian ministry with university and high school students with InterVarsity Christian Fellowship in eastern Ontario and Quebec. Through IVCF, he met his beloved Phyllis (Phyd) Crawley of Ottawa. They married in 1951. While he and Phyd raised their family of six children, Jim worked as a Chartered Accountant in Ottawa.

After Phyd's death in 1978, Jim pursued a long-held dream to study for pastoral ministry with The Presbyterian Church in Canada. Graduating in 1982 from Knox College, Toronto with the certificate of the college, he accepted an appointment as an ordained missionary to serve at Chatsworth and Dornoch, in the Presbytery of Bruce-Maitland. He was licensed and ordained by the Presbytery of Ottawa on June 27, 1982.

On January 21, 1986, he was received back into the Presbytery of Ottawa, and from April 1, 1986 served as stated supply at St. Andrew's Church (Aylmer), Gatineau for a number of years. The recommendation of the committee of the presbytery conducting the regular visitation to this congregation, adopted by the court on March 21, 1989 was "that the Rev. James Philpott be commended for his valued and supportive ministry of Word and Sacrament to this small congregation, seen as precious, above full value, 'pressed down and running over' by the congregation". Upon his retirement, when not supplying various pulpits, Jim attended St. Paul's Church, Ottawa. In his final years he resided in Perth, where he shared in fellowship at St. Andrew's Church; on January 20, 2004, his name was transferred to the appendix to the roll of the Presbytery of Lanark and Renfrew.

Jim is survived by his brother Herbert; his daughter Jan (Reiner) Kuehn; his sons Stephen (fiancee Beth Driscoll); Mark (Pam); John (Alison); and Pep (Jane); his daughter-in-law Tanya; eleven grandchildren; and four great-grandchildren. He was predeceased by his parents; his sister-in-law Muriel; his wife Phyllis; his son Peter (2007); and two granddaughters: Emily Ruth (1986); and Emily Katherine (1991).

James Philpott will be remembered for his love of family, of reading and music, for his wit, but above all for his love for Christ. He was a man of the word of God and of prayer, and was the "fragrance of Jesus" which lingered long with those whom he met.

The funeral was held at St. Andrew's Church, Perth, on April 6, 2011, conducted by M. Savage, assisted by E. Stevens, with representatives of the Presbyteries of Lanark and Renfrew; Ottawa; and Kingston in attendance. A private family interment followed on April 7, 2011 at Beechwood Cemetery, Ottawa.
